### PAYMENT OF ADDITIONAL LIQUIDATION DIVIDEND

Nigeria Deposit Insurance Corporation (NDIC) in its capacity as the Liquidator of the closed **Allied Bank of Nigeria Plc** is pleased to announce that it has completed arrangements to pay the 2<sup>nd</sup> liquidation dividend to depositors with excess (uninsured) deposits from the funds realised from the assets of the closed bank with effect from **Monday, 28<sup>th</sup> February, 2005**. The Corporation is on this occasion declaring liquidation dividend of **8kobo** per Naira having earlier paid a dividend of 6kobo per Naira to the depositors.
